Do not freeze. Label samples clearly, place EID tag labels OVER the blood tube label. While refrigeration is desirable it is not essential; please protect samples from extremes of heat or cold. 	<p>Test Results:</p> <ul style="list-style-type: none"> Test results will be provided in a timely manner through email. It is your responsibility to review the results. If you have any concerns or questions regarding the results, we encourage you to contact your animal health professional. We are not responsible for interpreting test results beyond the scope of our testing services unless explicitly agreed upon.
<p>Milk Samples:</p> <ul style="list-style-type: none"> Please use screw top plastic containers for milk samples. Min. 3ml per sample. Please keep refrigerated and pack with ice packs in a chilly bin. <p>Individual Faecal PCR:</p> <ul style="list-style-type: none"> Please use screw top plastic containers for dung. Min. 3g per sample, ideally 5-10g (1 tablespoon approx.) Use a fresh glove to collect each sample and avoid cross contamination of samples. Label samples clearly. 	<p>Intellectual Property:</p> <ul style="list-style-type: none"> DRL retains ownership of all information and intellectual property derived from the analysis of samples submitted. <p>Pooled Faecal PCR (Pools of 10):</p> <ul style="list-style-type: none"> If sample pooling is requested, send individual samples as we will carry out the pooling in the lab, that way we can easily retest individual samples from positive pools as required. If a pool is positive, we will contact you concerning your preference for individual sample re-testing. Please use screw top plastic containers for dung. Min. 3g per sample, ideally 5-10g (1 tablespoon approx.) Use a fresh glove to collect each sample and avoid cross contamination of samples. Dung samples freshly deposited on the ground are acceptable if they can be unambiguously linked to their originator and land on an otherwise clean surface. 	<p>Payment:</p> <ul style="list-style-type: none"> All invoices are to be paid by the 20th of the month following (normal commercial practice). Samples that are in the lab by 9am on these days will be processed on the day. Your samples can arrive to the laboratory any day of the month and we will store them appropriately until the next testing day. If you require expedited service and need results outside of these days, you MUST submit the samples as URGENT and you will be charged the associated fee. Results can be expected within 5 business days of the testing day.
<p>*Urgent Sample Fee:</p> <ul style="list-style-type: none"> Selecting Urgent will incur a fee of \$75 per 100 samples, with a minimum charge of \$75. Results will be provided the next business day, after arrival at the lab, or you will not be charged the fee. Maximum number of samples for an Urgent order is 400.
